We, the undersigned appraisers, pursuant to our appointment by the CRWD, respectfully submit the following Appraisers' Report.

A. Purpose and Objectives.

1. Determine the benefits or damages to all lands affected by the referenced project as required by MNL 103D.715.4.
2. Prepare a statement listing the property and corporations benefited or damaged or otherwise affected by the improvement stating the proposed amount to be assessed against each benefited property.

B. Implementation

1. Determination of benefits. Benefited properties were defined as "All property, including property owned by the state or a political subdivision receiving direct benefits, including assessment for drainage, recreation, commercial navigation, disposal of sewage or waste material, bank stabilization, flood control, land reclamation, prevention of siltation, control of erosion, and maintenance of lake levels."

The following improvements can be expected to result from implementation of the project according to the Engineer's Report dated June 22, 2011.

1. Preserve the aquatic ecosystems and water quality of Cedar Lake.
2. Preserve the beneficial uses of Cedar Lake including boating, fishing and swimming.
3. Expand the residents of Cedar Lake knowledge and understanding of AIS.

The project was initiated by a petition received by the Board of Managers on May 21, 2011, and the Board of Managers unanimously voted on June 8, 2011 to order an Engineers Report for the proposed project.

The Engineer's Report was received and filed by the Managers on June 22, 2011. After filing the Engineer's Report, the Managers passed a motion on June 22, 2011, appointing Appraisers and ordering an Appraiser's Report on the project.

The District appointed the Board of Managers as appraisers for the project in association with MNL 1030.721 and authorizes and directs them to determine the benefits or

The District appointed the Board of Managers as appraisers for the project in association with MNL 1030.721 and authorizes and directs them to determine the benefits or damages to all lands and properties affected by the project proposed in the Engineer's Report.

C. Method of Appraisal

1. To determine the amount each parcel was benefited, all benefited property was assigned a uniform class as follows:

Class I - A property owner with one or more contiguous parcels having access to Cedar Lake.


Each parcel in the class described above was assigned one unit of benefit. Additional units of benefits were assigned where the parcel was attached to additional or dividable parcels.


D. Allocation of Benefits

Table 1 shows the number of units of benefit found to be assessable and the amount of the assessment against each unit. The project costs for this assessment were estimated to be \$80,000. This includes the direct costs and the indirect costs and are assumed to be payable over a five-year period.


Attached is a list of all property and corporations benefiting from the improvement showing the amount of benefit and the amount to be assessed against each parcel. No parcels were found to be damaged.


