# CITIZEN ADVISORY COMMITTEE MEETING MINUTES Thursday April 14, 2022 – 7:00 PM Via Zoom

#### 1. Call to Order

Keith. Augusta, carpers always out spearing. Slowed down some. Suspects they're not reproducing as much

Phil. Louisa and Marie carp fisheries. Want a baseline/ data point to do a study. 100lbs/acre. \$4-5k survey on their two lakes.

Rose. Seems like an effective intervention.

**CAC Motion 2022-04-04** by Haataja Second by Thelen to Support the CRWD Board in more aggressively managing rough fish through survey and other means of migration barriers or physical removal. Motion passed with no discussion and all in favor.
