Re: Clearwater River Chain of Lakes Restoration Project
Appraisers' Report of Benefits, Damages and Special Assessments

Gentlemen:

We, the undersigned appraisers, pursuant to our appointment by the Board of Managers, respectfully submit the following revised Appraisers' Report.

A. Purpose and Objectives

1. Determine the benefits or damages to all lands affected by the referenced project as required by MSA 112.50 Subd. 1.
2. Prepare a statement listing the property and corporations benefited or damaged or otherwise affected by the improvement stating the proposed amount to be assessed against each benefited property.

B. Implementation

1. Determination of benefits. Benefitted properties were defined as "All lands, including lands owned by the State of Minnesota or any subdivision thereof receiving direct benefits. Direct benefits include, but are not limited to, assessments for drainage, recreation, commercial navigation, disposal of sewage, bank stabilization, flood control, land reclamation, prevention of siltation, control of erosion and maintenance of lake levels." MSA 112.501, Subd. 2 (1).

The Watershed District Board has determined by unanimous resolution that only lakeshore properties immediately adjoining the lakes to be improved will directly benefit by the improvements and are therefore subject to assessment, in amounts not to exceed the benefits received, to pay the local share of the cost of the improvements.

The following improvements in water quality can be expected to result from implementation of the project according to "Application for Federal Assistance, Clearwater River Chain of Lakes Restoration Project, Phase II - Implementation Grant":

- 1.1 Reduction of nuisance weeds and algae
- 1.2 Improved fishing conditions
- 1.3 Improved water clarity
- 1.4 Enhancement of all contact uses of the water

We have consulted with the township assessor relative to recent sales of unimproved land at Lake Sylvia, Cedar Lake and Clearwater Lake. The water of Lake Sylvia and Cedar Lake is classified by the Minnesota Pollution Control Agency as significantly better than that of Clearwater Lake. The recent sales indicate values of \$400 per front foot on Lake Sylvia, \$340 on Cedar Lake and \$250 on Clearwater Lake, indicating a significant correlation between water quality and property values.

In addition, local experienced realtors have noted a considerable turnover of properties on Clearwater Lake in recent years due in significant part to the deteriorating water quality.

2. Method of appraisal. An appraisal of benefits derived from improved water quality in lakes is largely a matter of opinion about which persons may differ. It is a matter of estimate and forecast and not one of absolute certainty. Consequently, we have relied on accepted methods for measuring benefits as described in the "Encyclopedia of Real Estate Appraisals," Prentice Hall, page 729. One method of analyzing benefits is called "Cost to Cure." Assuming that the cost to cure the water quality problems identified in the referenced grant application is equal to the benefits received by the affected properties, the benefits are equal to the total cost of the restoration project minus the cost of monitoring and evaluation and are estimated to be \$1,801,335 (Table 2).

To determine the amount each parcel was benefited, all benefited property was divided into nine uniform classes as follows:

Class 1 - A parcel or any number of contiguous parcels of lakeshore providing the owner with unlimited access to the lake. This class was assigned one unit of benefit.

Class 2 - A parcel or any number of contiguous parcels of land having a deeded access to lakeshore shared with other landowners. This class was assigned one-fourth unit of benefit.

- Class 3 - Resorts and other improved properties deriving income from rental units. This class was assigned one unit of benefit plus one-fourth unit for each permitted rental unit.
- Class 4 - Campgrounds. This class was assigned one unit of benefit plus one-tenth unit for each unimproved permitted campsite.
- Class 5 - Commercial property. This class was assigned one and one-half units of benefit.
- Class 6 - Public accesses owned by the State of Minnesota. This class was assigned one unit of benefit.
- Class 7 - Tax exempt park land. This class was assigned one unit of benefit for each non-contiguous parcel.
- Class 8 - Agricultural land. This class was assigned one unit of benefit for each parcel, or any number of contiguous parcels providing the owner with unlimited access to the lake. Agricultural lands are subject to deferment of special assessments under the Green Acres Act upon application to the county making the assessment.
- Class 9 - Unsold subdivided parcels. Lands in subdivisions of Class 1 and 2 properties were assigned the appropriate unit of benefit for each unsold parcel.

3. Allocation of Assessments

The assessment procedure is based on the theory that a lake restoration project whose goal is to improve water quality by the removal of phosphorus at various points in a chain of lakes will be of equal benefit to all properties downstream from the improvement. Since the benefits from five of the projects are lake-wide, the lakes benefiting from each project are identified as follows:

1. County Ditch 20 Wetland Treatment System - Betsy, Scott, Louisa, Marie, Mill Pond, Caroline, Augusta, Clearwater, Grass and Wiegand.
2. Kingston Wetland Treatment System - same as above.
3. Annandale Wetland treatment System - Clearwater, Grass and Wiegand.

4. Hypolimnetic Alum Treatment of Lake Augusta - Augusta, Clearwater, Grass and Wiegand.
5. Upper Lakes Reclamation - All of the above lakes plus Union Lake.

The sixth project identified as "Lake Augusta Erosion Control" directly benefits a group of properties whose only access to the lake is a channel which has been completely filled by sediment from gully erosion. An engineering study has determined that phosphorus in an amount equal to approximately one percent of the total phosphorus to be removed by all the projects is reaching the lake as part of this sedimentation. The lakes benefiting from this phosphorus removal are Augusta, Clearwater, Grass and Wiegand. The cost of restoring the lakeshores of the directly benefited properties will be assessed against them on a front foot basis (Note A, Table 2).

Tables 1, 2 and 3 demonstrate the allocation of assessment using the cost estimates found in the Engineer's Report. It should be emphasized that these are estimates only and not final assessment figures.


Table 1 lists the lakes to be benefited by the improvements, the number of benefited units on each lake and the number of benefited units in each county. Table 2 lists the estimated cost of each improvement, the local share of the cost to be raised by special assessment against the benefited properties, the lakes benefiting from each improvement and the number of units benefited by each improvement. Table 3 lists the benefited lakes, the number of benefited units on each lake, the proposed assessment against each unit and the total assessment against each lake.

4. Allocation of benefits. Figures from Table 2 show the total cost of the project minus the cost of monitoring and testing plus reports and evaluation to be \$1,801,335. ($\$2,069,435 - \$268,100 = \$1,801,335$). Dividing by the total amount of the local share to be assessed ($\$489,557$) shows the cost to cure benefits to be 3.68 times the amount of the assessments.
5. Formula for the assessment per benefited unit. The local share of the cost of each improvement was divided by the total number of units benefited by the improvement to determine the cost per unit. Costs per unit for each improvement were applied to each lake according to the specific improvements benefiting that lake and totaled to arrive at the assessment per unit of benefit on each lake.

Attached is a list of all property and corporations benefiting from the improvements showing the amount of benefit and the amount to be assessed against each parcel. No parcels were found to be damaged by any of the projects. Where more than one parcel number appeared on the county records describing a contiguous property having one owner, all parcel numbers were listed and the assessment was pro-rated against each parcel.

The DNR has refused to issue a permit to reopen the channel which provides lake access to a number of property owners until the erosion which has completely filled the channel has been brought under control. Allocation of the assessment to pay the local share of this project is as follows:

A precedent for using front footage to allocate the assessment for restoring lakeshore to the affected properties on Lake Augusta was established by Wright and Stearns Counties when all the property owners on Lakes Louisa, Marie and Mill Pond were assessed on that basis for reconstruction of the dam at Fairhaven, which restored the lakeshores of the affected properties on those lakes.

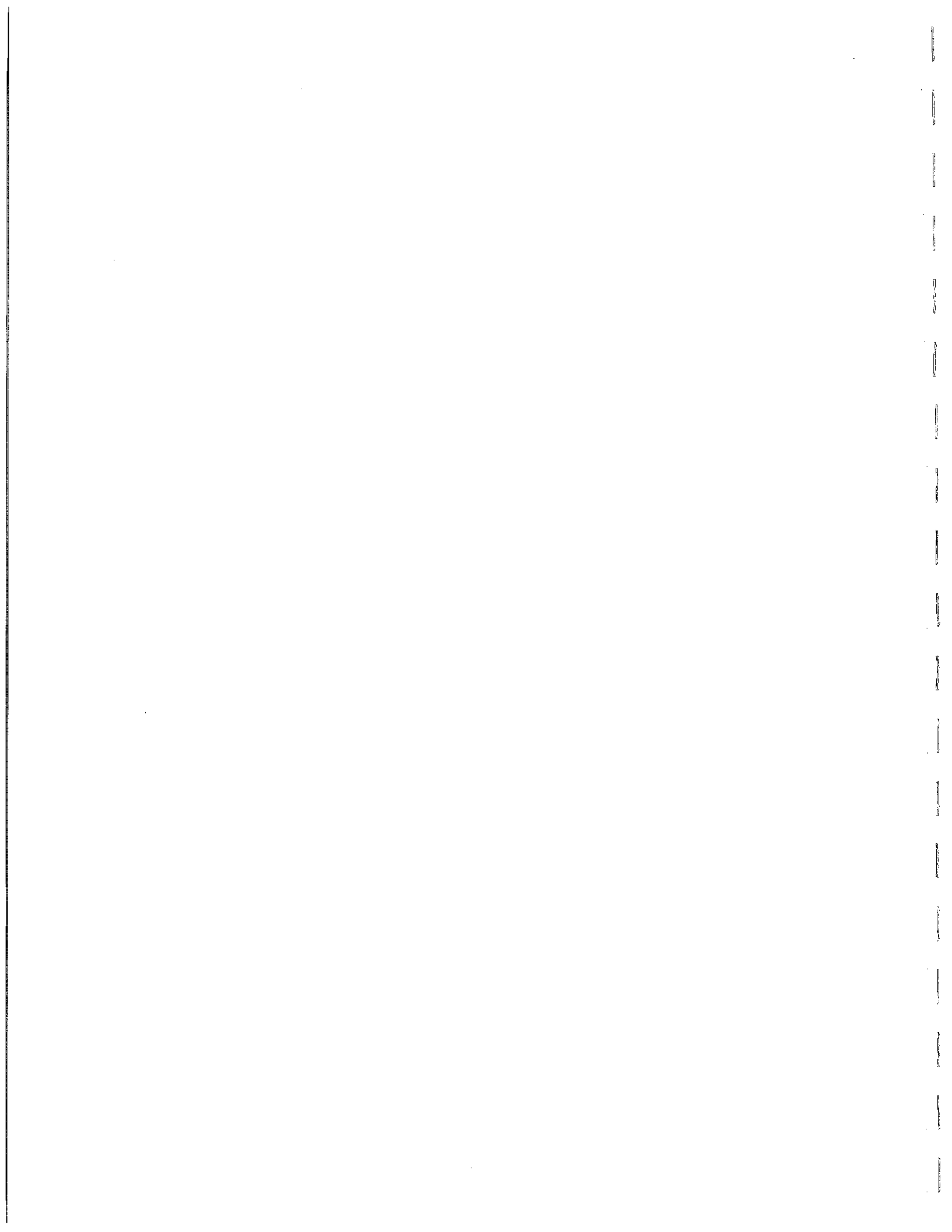

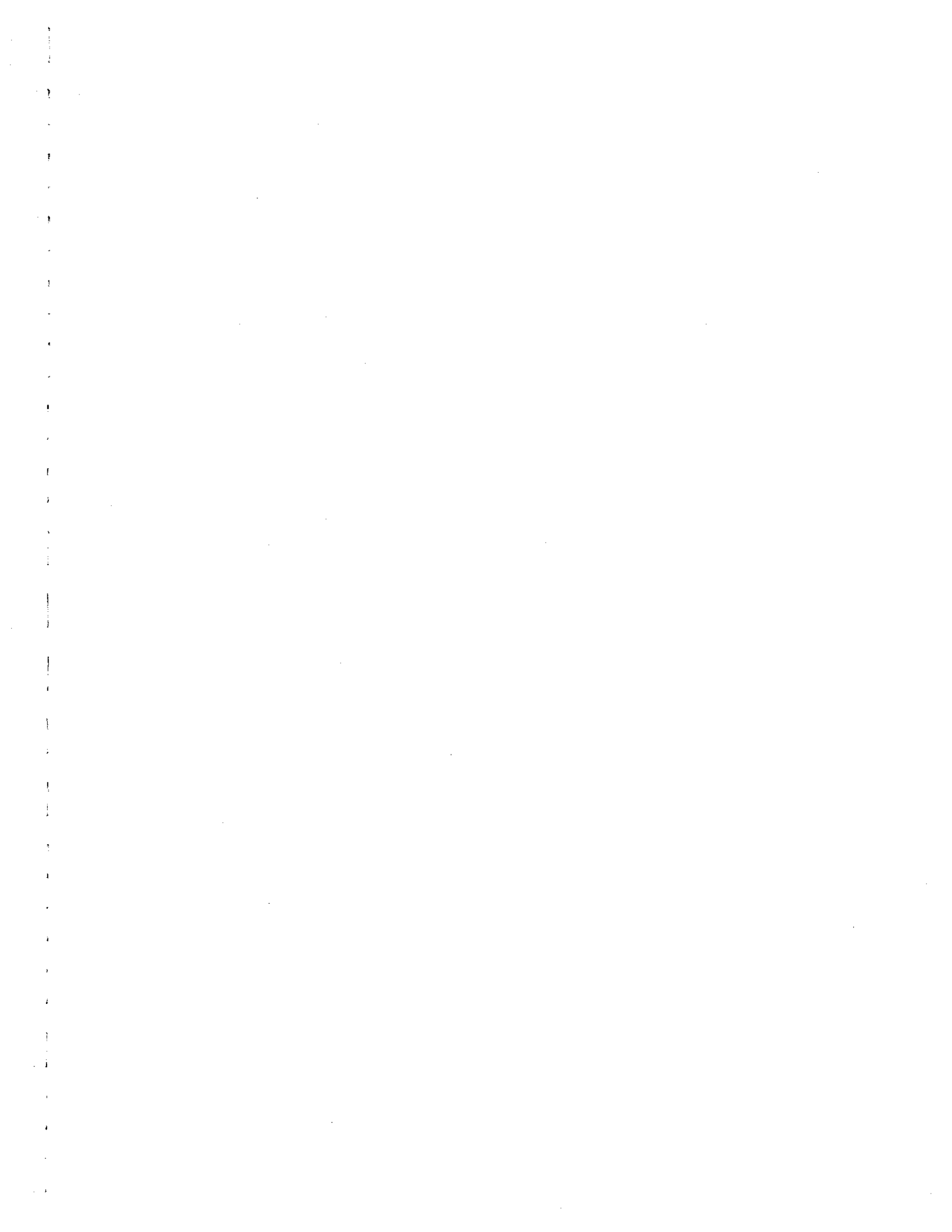
